FIFTEEN RUPEES

WHEREAS I, Swami Swatantranand, disciple of Swami Purnamend, resident of Dinamagar (District Gurdaspur aged sixty nine years, am a Sanyasi for the last 45 years and am a believer in the principles of Vedic Dharma as interpretted and prepounded by Maharaahi Swami Dayanand Baraswati, the founder of the Arya Samaj. I have full and abiling faith in the SATYARTH PRAKASH, the fifty-one principles of the "Kantavyama tavya" appended thereto and the ten principles of Ar Smaj. I look upon meat, fish and egg-eating and taki of alchoholic drinks assinful. The term"Vedic Dharma whereever it appears in this deed means all and only that which has been stated above. AND WHEREAS for a long time past it has been my desire to establish n 'Hath' where Arya-Sanyasis, Vanprasthis, Sadhua and Brahmcharis could came and stay for the study of Yed Dharm and improvement of their mental, moral and bodily health and which should provide them with bos and ledging and with complete social, educational an madical-aid-facilities and which should for this purpose and the general benefit of the community (Hankind): (a) start and maintain an AUSHADNALAYA. s a means to the propagation of Vedic Dharma, where medicines and medical aid be province free as far as possible; (b) set up a library and a 'pathahala' for providing religious education in order to inculcate the principles of vedic Dharma: (a) undertake public ensure the protection and progress of the MATH during my life-time and thereafter I have after deep deliberation and careful consideration decided to provide as under:-

- 1. That the "DAYANAND MATH" (which will mean the present institution at Dinanagar described in parathree above as well as its future extensions and branches and other allied institutions which may merge in it in due course) shall be governed and managed by an ADHYAKSHA (Governor) who shall be a Sanyasi, with the aid and advice of Advisors and provided below.
- 2. I hereby constitute and appoint myself as the first ADMYAKSHA of the hayanand math and after my death my nominee, to be uppointed in the prescribed manner in due course, shall succeed to the office.
- S. The ADHYAKSHA of the Eath shall be a staumen Arya Samajist and an active believer in the principles of Vedic Dharma as defined in the first paragraph of this deed. He shall nominate his own successor who shall be a Samyasi possessed of the like convictions and qualifications.
- 4. In case an ADHYARSHA dies without sopoin ing his successor or when there is a vacancy in the office caused by his resignation. disamissal or refuse to act the Advisory Committee shall make the necessary appointment with the consent and approval of the Executive Committee (Antarang Sabha) of the Arya Pratintahi Sabha Punjab, Curdutta Bhawan, Lahore, and in case of difference of opinion between the said Advis Committee and the Executive Committee of the A.P. Sauh the ADYARHEMA shall be appointed by the Sarvdeshalt Dayaranad Bhikhalm Mandal Taxalanum Mataria.

That in case of difference of opinion between the Advisory Committee and the Adhyaksha on any question of polloy or routine administration the Adhyaksha shall send back the matter to the Committee with his written opinion thereon to be reconsidered at its next meeting and if the committee again disagrees the decision of Adhyaksha shall be carried out as if it had been duly passed by the Committee and shall be recorded as such in the minute-books. 7. That there shall be an Advisor, Committe se consisting of not less than aix and not more than eleven persons. The first committee shall consist of the following eleven gentlmen -1. All vacancies in the personnel of the Advisory Committee shall be filled up by the remaining members from amongst Arya Samajists who have full, coti and living faith in Vedic Dharma. 9. A member of the Advisory Committee shall osess to be so (a) on death. (b) on retirement by resignation. (o) on dismissal. (d) on conviction for any offence involving moral turnitude. (e) on being adjudged insolvent. (f) on coasing to be an Arya Samajist. (g) on otherwise becoming incapable to act as such. The Adhyskaha of the Wath shall also cease to be so on the happening of any of the above eventualities. 10. The Adhyaksha shall ex-officie be the President of the Advisory Committee. The Advisory Consider shall elect its own Vice President and Secretary and a Treasurer. The Secretary shall in consultation with the Adhyakaha of the Math be the convenor of all the meeting The agenda of the meetings will be fixed up by the Secretary with the approval of the Adhynkaha. 11. The Committee shall keep a record of all ite meetings and will frame all the necessary rules and regulations for its meetings and the conduct of the whol affairs of the Math. 12. The Committee shall aid and advise the Adhysksha in the menagement of the property of the water and in all its affairs. A statement of income and expenditure shall be placed every year before to aver

The Advisory Committee shall have the power to discuss him with the consent and approval of the Antarang Sabha of A.P. Sabha Punjah and appoint another Adhyaksha in his place in the manner laid down in clause 4 above. Moreover, in case the Adhyaksha refuses to act or leaves his office of lies without appointing his successor of otherwise becomes incapable, by illness or otherwise to do so the Advisory Committee shall in the like manner fill up the vacancy and until the vanancy is so filled the entire property of the Math shell vest in its Secretary.

(Note) :- (In case I die without nominating any person to succeed me as Adhyaksha of the Math, Pt. Ram Chandra , Sidhant Sharomani, Dayanand Math. Dinamagar. shell be the Adhyaksha, provided he forth-with becomes a Saniaski, otheriwse the Adhyaksha shall be appointed according to the rules laid above. The appointment of a successor by the Adhyaksha shall be duly notified by him to the Advisory Committee in writing and will be duly recorded in the Minute Books of the Committee. Mo appointment will be valid unless it has been thus recorded. A dismissed Adhyaksha shall not exercise the power of nomination and any nomination by him which had been recorded within two years of the date of his dismissal shall be invalid and the Advisory Committee shall make its own appointment in the manner heredefor stated as if there had been no valid appointment). The Committee small have power to dismiss its own members

prior written permission of the Advisory Committee notwithstanding anything contained in clauses 5 and \$12 above.

Committee shall be held whenever necessary in the opinion of the Adhyeksha and at least once every quarterly: Provided that the Secretary shall on the requisition of three members of the Committee call a meeting within fifteen days from the receipt of the requisition failing which any of the requisitioning members may call the same at Dinamagar only.

It is since 1941 successfully running an Aushadhalaya where medicines are given free, Kathas, Havan-Tajnas and other religious gatherings are being held there far the propagation of Vedic Dharma and it is already sending out preachers of Vedic Dharma and by these and other means the MATH is expanding day by day both by the addition of lands as well as by buildings thereon with th help of donations and endowments thereto.
